

### **Updated Frequently Asked Questions Released**

For Parents & Providers (Abbreviated)

Q: Who can access child care?

A: Essential persons and parents who work in businesses, organizations, and facilities opened by the Governor.

Q: When will all child care programs open to all parents?

A: Opening child care to all parents is part of the second phase of recovery.

Q: If my jurisdiction has not fully opened, can I operate my child care with the guidance given to the rest of the state?

A: Care programs must follow local jurisdiction restrictions.



### **Updated Frequently Asked Questions Released**

For Parents & Providers (Abbreviated & Continued)

Q: Is there a cost for child care services?

A: Essential persons receive child care services at no cost until June 7, 2020. Beginning June, 8, 2020, all parents pay tuition.

Q: When can I serve more than a maximum of 10 persons per room?


A: The Governor has prohibited gatherings of more than 10 persons. Until the Governor increases this, child care programs are limited.

Q: Can I use serve the maximum group size in spaces in large rooms sectioned off by half-walls, partitions, and other barriers?


A: Yes, you may use large rooms sectioned off by half-walls and other barriers if that is how you operated previous to COVID-19

#### **About MIECHV**

- Established in 2010 under the Affordable
   Care Act
- Federally funded by the Health Resources and Services Administration (HRSA)
- Reauthorized for five years (through 2022)
- Uses evidence-based home visiting models (22 models nationally)

#### **Capacity and Need**

**Finding**: According to findings from the 2019 Preschool Development Grant Needs Assessment (n=472) many parents in Maryland do not know about home visiting programs or do not find home visiting programs to be accessible.

#### Capacity and Need cont'd

**Finding:** The need for home visiting services exceeds the current capacity.

- The state is currently serving around 22% of the families estimated to be eligible for service
- Out of the 24 jurisdictions, 14 (58%) serve less than half of the families estimated to be eligible for service



#### Capacity and Need cont'd

**Finding:** Across Maryland, programs struggle with family retention Out of the total of 4,357 women who enrolled in home visiting programs across the state, 1,229 women disengaged from services in FY 2019

being unable to contact or locate families (18%)	child transitioning to center-based care (5%)			
scheduling conflicts (15%) of which three were due to clients getting new jobs	child aging out of program (5%)

#### **Guiding Questions**

Maryland's comprehensive needs assessment is focused on the following guiding questions:

- What communities in Maryland have a high concentration of risk factors?
- What are the specific needs of eligible families living in "at risk" communities
- To what extent are home visiting programs providing high quality services in Maryland?
- What is Maryland's capacity for providing substance abuse treatment and counseling to individuals who need such treatment and services
- To what extent do home visiting programs coordinate and collaborate with other early childhood programs in the state?



#### **Areas of Risk: Elevated Indicators**


We have used ArcGIS mapping to inform and visually display areas of risk in this needs assessment. Indicators were established though HRSA as well as add ons with stakeholder input. The four overarching areas were the driver for the direction of the qualitative design.

- Adverse Perinatal Outcomes: eleven indicators having to do with the health of the mother and child during the perinatal period
- Socio-Economic Indicators: five indicators having to do with the socioeconomic wellbeing of a community
- Child Maltreatment: Two indicators having to do with the safety and wellbeing of children
- Other: Three indicators having to do with other aspects of the community

#### What will be the core content of the guide?


- The guide will be framed around the six goals outlined in Maryland's Prenatal-Age Eight 2020-2025 Strategic Plan

- Response rate of 44%
- Responding programs/providers
  - Open, 68%
  - Closed, 32%



- All jurisdictions of the State represented
- All types of care represented
  - Family Child Care, 69%
  - Child Care Centers, 20%
  - Large Family Child Care, 3%
  - Letter of Compliance, 1%
  - Nursery Schools, 2%
  - Pre-K, 1%
  - School Age Care, 2%
  - Unknown, 2%



- Financial Loss due to COVID-19
  - Yes, 67%
  - Not yet, but I expect to, 14%
  - No, 19%
- On average, providers experience in monthly losses
  - \$35,000 center based programs
  - \$4,800 family child care
- Largest expense
  - Rent/Mortgage, 54%
  - Employee Wages, 24%
  - Supplies, 12%
  - Utilities, 4%



- Continue to pay employees
  - Yes, 24%
  - No, 47%
  - Other, 29%
- If closed, are employees applying for unemployment
  - Yes, 28%
  - No, 72%
- Have you or will you apply for SBA Economic Injury Disaster Loan
  - Yes, 24%
  - No, 68%

- Apply for SBA Paycheck Protection Program
  - No, 100%
- If a FCC Providers, did you apply for unemployment insurance as a result of the CARES Act
  - Yes 20%
  - No, 80%



- What will happen to your business if families keep children home for extended periods or if you are closed for an extended period of time
  - Close program currently, 51%
  - Layoff employees, 26%
  - Reduce program hours, 18%
  - Reduce employee hours, 18%
  - Increase tuition/fees, 17%



- What kinds of support might your business/program need:
  - Grants to pay for fixed costs, 72%
  - Grants for reopening costs, 29%
  - Regulatory relief, 41%
  - Help with applying for governmental assistance, 41%
  - Grants to pay staff during closure, 37%
  - Low interest loans, 19%
