The Moore-Miller Administration's Proposed Historic Investment in the Child Care Scholarship Program

\$500 million total proposed budget investment from the Moore-Miller Administration

- The FY26 funding is a:
 - 392% increase over FY23 funding levels, and
 - 336% increase over FY22 funding levels.

*All eligibility/income documentation must be received and verified to make a determination for benefits. The application process may take up to 30 days.

Effective December 15, 2024, the income eligibility requirements for the Child Care Scholarship program have been increased to allow more families to qualify for assistance.

- Family of two = \$76,117 (previously \$61,222)
- Family of four = \$111,936 (previously \$90,033)

Prekindergarten Funding Overview

- 1. Blueprint Formula Funding
 - Current Prekindergarten Expansion Grantees only
 - Prekindergarten expansion slots from FY 25 will be converted to Blueprint slots in FY 26
 - No application is required; however, grantee must be in good standing with Blueprint and grant requirements (see next slide)
- 2. Prekindergarten Expansion Grant
 - New Applicants
 - Current Blueprint Formula Funding Grantees seeking to increase slots for FY 26



Prekindergarten Funding Overview

A current Blueprint Formula Funding grantee is considered "in good standing" if the following conditions are met:

- Maintains a Lead Teacher that meets the Blueprint Requirements
- Maintains a Maryland EXCELS published quality rating of Level 3 or higher
- In compliance with grant reporting requirements and fiscal guidelines
- Not under a corrective action plan for fiscal concerns or instructional concerns

- Application Submission: Online Only

- All applications must be submitted in English.
- **Funding** per slot for SY25–26: \$14,473



Prekindergarten Expansion Grants for 2025-2026 School Year

•Eligibility: This funding opportunity is designed for those who deliver prekindergarten services and participate in Maryland EXCELS including:

oLocal Education Agencies (LEAs) or qualified vendors (as defined in <u>COMAR 13A.06.02</u>) and private providers who:

ohold a valid license, and

ohave not incurred any serious health or safety violations in the last year.
oHead Start programs

- Application Deadline: April 11, 2025
- Technical Assistance Sessions: March 4*, 5, 6*, 12, and 19th from 1:00-2:30 pm
