











### **Historical Child Enrollments**




### Percent Change in Non-TCA Enrollments by County, Dec 2021 to Jan 2022



Overall, Non-TCA enrollment **increased** slightly over the month.

The overall increase was mostly caused by a jump in Montgomery County enrollment. Because of its larger population, it's percent change looks small, however, enrollment **increased** by **72 children**.

Despite increases, Non-TCA enrollment in Caroline, Dorchester, Garrett, and Kent Counties all **decreased** by **over 4%**.



### Average Copay per Child




Average **co-pay per child** per month decreased to **\$81** this month.

Total cost of care per child (co-pay plus scholarship) decreased to **\$743** this month, down **1.4%** from last month.


Summer months (June, July and August) typically show higher co-pays per child, while non-summer months (September through May) show lower co-pays per child.

### Average Expenditure per Child




Average CCS expenditure per child per month decreased **\$8** from last month to **\$652**.

### Enrollment by Provider Type



Center care enrollment totaled **11,686** this month, **78%** of the total, **up 2.7%** from last month. Family care enrollment totaled **3,131** this month, **21%** of the total, **down 0.7%** from last month. Informal care enrollment totaled **142** this month, **1%** of the total, **down 3.4%** from last month. Licensed care served **99%** of all children recieving scholarships.

#### Scholarship Paid Providers




### Scholarship Paid Providers (PP)

Active licensed providers that recieved CCS payments during the month.


The total number of CCS paid formal providers this month was  $\textbf{2,249},\,\textbf{up}$  .76% from last month.

Centers were up by 1.8% to 1,230; Family Homes decreased 0.5% to 1,019; Informal providers decreased 3.2% to 61.
