








Enrolled Children by Zip Code








Percent Change in Non-TCA Enrollments by County, Jan 2022 to Feb 2022

TCA enrollment in Calvert and Talbot Counties dropped to zero over the month, joining Garrett and Queen Anne's Counties at zero enrollment.



Average Copay per Child




Average **co-pay per child** per month increased to **\$82.7** this month.

Total cost of care per child (co-pay plus scholarship) increased to **\$751** this month, up **2.5%** from last month.

Summer months (June, July and August) typically show higher co-pays per child, while non-summer months (September through May) show lower co-pays per child.







Average CCS expenditure per child per month increased **\$16.4** from last month to **\$668.5**.

Enrollment by Provider Type




Center care enrollment totaled **11,969** this month, **78%** of the total, **up 2.4%** from last month. Family care enrollment totaled **3,198** this month, **21%** of the total, **up 2.1%** from last month. Informal care enrollment totaled **160** this month, **1%** of the total, **up 12.7%** from last month. Licensed care served **99%** of all children recieving scholarships.

Scholarship Paid Providers (PP)

Active licensed providers that recieved CCS payments during the month.

The total number of CCS paid formal providers this month was **2,237**, **down .53%** from last month.

Centers were **down** by **.81%** to **1,220**; Family Homes **decreased 0.2%** to **1,017**; Informal providers **increased 11.5%** to **68**.


Scholarship Paid Providers (PP) as a Percent of Active Licensed Providers

Active licensed providers are providers that held an 47.6% effective CCS license during the month.

31.3% of all licensed child care centers were paid for providing care to enrolled children this month, **down .1 percentage points** from last month.


Active licensed <u>formal</u> child care providers totaled **7,137** this month. Centers numbered **2,563** and Family Homes **4,574**, both **down slightly** from the month previous.

Annual Provider Openings




Home Openings
