CCDF Reauthorization encourages states to set authorization at 52 weeks and not to reduce services, if a parent loses their approved participation activity between determinations, because continuity impacts the socio-emotional development and wellbeing of children. Because Maryland does not have a way of monitoring when a parent loses authorization once determined eligible, the most consistent way to address providing continuity of care to all children is to leave children enrolled until the subsequent determination – at that time, the parent will have to be engaged in an approved activity.
