Maryland Accreditation Fund assists centers with the cost of instructional materials associated with pursuing Maryland Accreditation.

This can include materials for centers, books,
 math manipulatives, science equipment and more.

## Bonus Basics

## Maryland EXCELS Bonuses:

- Participating programs that publish a first-time rating, a higher quality rating, or republication of a quality rating 5 .
- Bonuses will be based on publishing actions as of July 1, 2022.
- Bonus payments are in progress.
- There are no requirements for how the bonuses are spent.
- Bonuses are ongoing as outlined in the Blueprint for Maryland's Future.


## Bonus Amounts for Child Care Centers

Bonus amounts for child care centers will range from \$150-\$13,500.

How to Participate in Maryland EXCELS
Maryland EXCELS uses nationally recognized quality standards and best practices to promote quality program improvement in Maryland's Child Care Centers, School-Age Child Care Programs, Family Child Care Homes and Public Prekindergartens.

The following programs are eligible to participate in Maryland EXCELS:

- All licensed Child Care Centers (including school-age only and Letter of Compliance programs) and registered Family Child Care Homes that are open and operating. (Programs are ellgiof or Child Care -
- Public Prekindergarten programs operating under a school approval number.

To complete a program application to participate in Maryland EXCELS, begin by logging into your user account or by creating a user account, if you do not already have one.

## Child Care Scholarship Updates

On October 20, 2022, Superintendent Choudhury sent a program memorandum to the child care community advising of upcoming changes effective January 2, 2023.

## What is the Advance Payment Process?



The advance payment process allows for MSDE to pay providers in advance.

Advanced payment is based on enrollment.

Issue advance payments based on enrollment for that advance payment month.

## How will this work?



MSDE will divide the total amount a provider is due each month into two payments: $1^{\text {st }}-14^{\text {th }}$ and $15^{\text {th }}$ - Last day of the month.

Providers will receive advance payments based on the number of active receipted scholarships.

A monthly payment email notification will be sent to providers with details of the advanced payment.

## How will this work?

Providers must
continue to turn in
signed invoices each
service period.


Payments will be recouped for providers who do not return the invoice.

True Up reconciliation process will begin in April and each month thereafter.

## What is True Up?

## The True Up Process

The reconciliation process, may increase or decrease a provider's payment, after the advance payment month has been paid.

## An example of True Up:

1. Child enters care on January $20^{\text {th }}$
2. Child was enrolled after the advance payment was processed for January
3. Provider will be paid for the child's enrollment in February and subsequent months
4. Provider will receive the payment adjustment in April for January's payment

## Advance Payments

This Checkwriter Report is for your second advanced payment!
In October, State Superintendent of Schools Mohammed Choudhury announced a new policy for advanced, enrollment-based payments.

MSDE will now pay providers for the number of children enrolled in a month at the beginning of the month, as of January 1, 2023, onward. In the past, you were not paid until after a service period ended.

The second Child Care Scholarship advanced payment under this policy has now been issued. This advanced payment amount is based on the number of children with enrollment dates as of January 6, 2023.

A list of the amount paid for each scholarship will be mailed separately next week. This will provide the information you usually receive in the Invoice Detail Report.

Payment amounts have been adjusted for scholarship end dates and EXCELS Tier payments, if applicable. Registration fees are not included in this second payment. Union dues, and recoupment are not deducted in this payment. MSDE will reconcile registration fees and union dues later this spring.

Each monthly advanced payment will be issued in two payments. This payment is for the second half of the month. The first checkwriter payment was sent January 12 to 19 for the first half of the month.

## Advance Payments

## New True Up Reconciliation Process

Four months after each advanced payment, MSDE will reconcile your account based on actual scholarship enrollments for the month:

- If additional children were added after the advanced payment calculation, MSDE will pay an increased amount for the additional enrollment; and/or if scholarships were ended early in the month, a reduction will be taken in the amount MSDE pays.
- Adjustments will also be made for closures, unapproved holidays, and rate adjustments (such as child turning two).


## Avoid Overpayments!

Invoices are still required for each month's two pay periods, though attendance will not affect the amount of payment!

The invoice is due to MSDE 60 days from issuance. MSDE cannot accept late invoices. If an invoice is not submitted on time, MSDE is required to establish an overpayment to recover payments for all children that were enrolled for the service period.

Overpayments will also be established when children have more than 60 days of absences in a calendar year or a provider is closed for more than 10 consecutive days, more than once in a calendar year.
